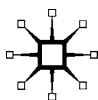

Acknowledgements

Neither by temperament nor by training am I a local historian. Entirely fortuitously, however, much of this book has been written over the past year on isolated North Head, Sydney Harbour, in my house on remnant army land soon to be National Park. The old Quarantine Station is my immediate neighbour on one side, the equally out-of-use Catholic seminary on the other side. The military fort lies on a third and to the east are huge cliffs dropping to the ocean. For years the telling historical geography of this liminal bit of metropolitan Sydney had been the object of my research – see details in Chapter 2. And for the past year, I have been able to take breaks from writing, and explore along the stone walls that criss-cross the headland in unexpected ways – walls which used to separate the first class from the steerage class immigrants-in-quarantine, the whites from the Chinese, the plague-victims from the army, the infected and the carriers from the dead, and everyone from the priests-in-training. The sanitary lines between *Purity and Pollution* began to interest me in my first book, and here I have both lived in and thought much about related, but different kinds of nineteenth and twentieth century delineations between the ‘hygienic’ and the ‘unhygienic’, the ‘fit’ and the ‘unfit’: imperial lines of racial segregation, lines of defence, lines of nation.

This writing time-and-place has been shared with important people in my extended family, and my thanks to them all: my twins Tessa and Oscar, Carolyn, Catriona, Nicholas and Lisa and Annabel. The Bruntons – especially Nicholas and Carol – have been generous and full of grace. My parents continue to provide every kind of support and interest.

I have been writing versions of these chapters for several years now. My thanks to readers of various drafts: Barbara Caine, Harriet Deacon, Catriona Elder, Stephen Garton, Mark Finnane, Bernard Harris, Claire Hooker, Philippa Levine, Roy Macleod, Renisa Mawani, Dirk Moses, Glenda Sluga, Carolyn Strange and Mick Worboys. I am grateful especially to Renisa and Mick for the opportunity of reading their unpublished essays on leprosy, from which I have learned a great deal.
