Preface and Acknowledgements

I am grateful to the students on the 'Television and Documentary' course at the University of Reading in 2004–05: Helen Dunworth, Jessica Garland, Rozzie Hughes, Alexandra Lishman, Alex Papadakis, Caroline Reed and Amy Tucker. Their ideas about Reality TV helped to shape my own, and their contribution has added valuable insights to this book. I am especially grateful to Alexandra Lishman, whose careful notes on our discussions reminded me of ideas that would otherwise have been lost in the to and fro of argument. My friend David Kail has made important comments and corrections to my ideas about the institutional position of Reality TV as a result of his experience of working in the television industry, and I am grateful for his insights. I presented some of the conceptual issues outlined in this book at the conference 'Reality TV: Contexts, Debates, Futures' at the University of Surrey, Roehampton in May 2004, where contributions from the participants have aided my work. Some of the work on the aesthetics of surveillance in Chapter 5 was suggested by John Gibbs's detailed studies of style and meaning in cinema, and I am pleased to be able to acknowledge the importance of his work on mise-en-scene to my analyses of programmes in this book. I have also been influenced by the approach of Sarah Cardwell to the specifics of television textuality that have modified some of my ideas on the subject despite some fundamental disagreements between us that still remain. My former colleague Helen Wheatley assisted by providing videotape copies of some programmes that I had missed and contributing to the stimulating research culture in the Department of Film, Theatre and Television at the University of Reading. An important component of that culture is the Centre for Television Drama Studies, and while the topic of this book is not exactly within its remit my colleagues and postgraduate students working in the Centre have given valuable intellectual stimulus. In that context, my colleague Derek Paget's expertise in factual television has been formative in shaping my thinking about Reality TV and its relationships with documentary traditions. This book has taken much longer to complete than I originally intended, and I am grateful to the editorial staff at Palgrave for initially suggesting that I write it, and for their continuing forbearance as deadlines came and went. As always, Lib Taylor deserves my profound thanks for her encouragement, support and love.
