**Janette Dillon** is Professor of Drama in the School of English Studies, University of Nottingham. She has published widely on medieval and early modern drama and literature, including recently *Performance and Spectacle in Hall's Chronicle* (Society for Theatre Research, 2002) and *The Cambridge Introduction to Early English Theatre* (Cambridge University Press, 2006).

**Teresa Grant** is Associate Professor in Renaissance Theatre and Director of Graduate Studies of the Centre for the Study of the Renaissance at the University of Warwick. She has published on early modern drama and literature, including recent essays in *The Myth of Elizabeth* (ed. Doran and Freeman, Palgrave Macmillan, 2003) and *A Cultural History of Animals* (ed. Kalof and Resl, 2007). She is currently preparing a monograph for Cambridge University Press on the uses of animals on the early modern English stage and is a general editor of *The Oxford Complete Works of James Shirley* (forthcoming).

**Mark Hutchings** is Lecturer in the School of English and American Literature at the University of Reading. The focus of his research and teaching is drama in performance, principally the early modern theatre, and he has a particular interest in perceptions and representations of the Ottoman Empire in English literature. Publications include 'Acting Pirates: Converting Robert Daborne's *A Christian Turned Turk*', in *Pirates? The Politics of Plunder, 1550–1650* (ed. Jowitt, Palgrave Macmillan, 2006), a jointly authored book with A. A. Bromham, *Middleton and his Collaborators* (Northcote House, 2006), and an edition of *Three Jacobean 'Turkish' Plays* for Manchester University Press (forthcoming). He is guest editor of a special issue of Shakespeare, 'Shakespeare and Islam' (Routledge, 2008).

**Barbara Ravelhofer** is Lecturer in English Literature at Durham University and Research Associate at the Centre for History and Economics, University of Cambridge. She has written on European spectacle of the Middle Ages and the Renaissance, virtual theatre, stage design, early modern attitudes to animals, Byron, editorial questions, and plagiarism. **Michael Ullyot** is Assistant Professor in English at the University of Calgary, Canada. His research is on the rhetoric of exemplarity and biographical self-consciousness, particularly in the Sidney, Essex, and Prince Henry circles. Recent publications include an edition for the John Nichols Project (University of Warwick), and essays in *Fantasies of Troy: Classical Tales and the Social Imaginary in Medieval and Early Modern Europe* (ed.
